Cancellation/Refund Policy

Had a change of heart? Not quite what you had in mind? We understand! That's why we offer FREE US returns – which we'll be happy to refund or exchange as soon as we receive the product back here! Within 28 days of receiving your purchase, (or 14 days for reduced or sale products) send the item(s) back to us via post. Just make sure your item is in its original condition with the tags still attached.

It couldn't be easier...

STEP 1: When we ship your order, we will include a returns form along with information on how to make a return. If you want to return any items, you must complete the returns form and enclose this with the items you are returning. Once complete, remember to pop it in with your return.

STEP 2: Simply detach the returns label provided with your order, attach it to the original package and follow the instructions on your returns form.

STEP 3: Take the package (with enclosed and completed returns form) to the Post Office. Make sure to ask for a proof of postage, and hold onto this until we can confirm we've received the goods back here, as without this we cannot be responsible for any items that fail to reach us.

We'll send you an email letting you know whether a refund or exchange has been processed. This is usually done within 2 business days of receiving your return into our warehouse.

Any refund will automatically be issued to the payment method you used to place your original order. This typically takes 5 business days in the US, depending on your payment method issuer.

In the unlikely event that an item is returned to us in an unsuitable condition, we may have to send it back to you. Your statutory rights are not affected by our returns policy.

The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. Class Action Waiver

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER.
